

# **COMMUNAL POND OF SAINT-VAAST-LES-MELLO**

## **FISHING REGULATIONS**

### **SENSITIVE NATURAL SPACE DUMARAIS DE CHANTERAINES BY**

#### **MUNICIPAL DECREE N ° 20/2015 of 30 APRIL 2015**

The pond is the property of the municipality which rents the fishing rights. An agreement relating to the territorial exercise was signed between the federation and the municipality.

Rules:

#### ARTICLE 1:

Annual membership cards for the communal pond of St Vaast les Mello can be allocated to people who request them under conditions of being the holder:

- the adult fishing permit for over 18s (euros) (74
- the interfederal fishing card for adults URNE (100 euros)
- the minor fishing license for 12-18 year olds (20 euros)
- the discovery fishing card for children under 12 (6 euros, line) 1
- the promotional women's discovery fishing card (35 euros, 1 line)
- the day pass (12 euros)
- the weekly card valid for 7 consecutive days (33 euros)

The members must comply with the laws, the decrees in force in the department and the municipal decrees.

The fishing permit is strictly individual, it is valid for one calendar year and it is not transferable.

### **PRICES OF ACTIONS for fishermen from outside the Municipality**

Action all year round	18 years and over
2 rods	100 €
4 rods	120 €

#### **ARTICLE 2:**

- The number of rods is 4 for carp and 2 maximum for predators.
- Night carp fishing is prohibited.

- The hours of fishing are those recognized by law: half an hour before sunrise and half an hour after sunset.
- Fishing from a boat or other floating means is prohibited.
- Fishing with gear is prohibited (baiting and laying of lines by radio-controlled floating means are prohibited).
- The opening for predators is done on the date fixed by prefectural decree. (see town hall regulatory display)
- Any pike or pike perch less than 0.60 m must be returned to the water immediately.
- Catfish caught should never be returned to the water.
- Fishing is prohibited if the body of water is frozen, even partially.
- Fishing is prohibited in the fishing reserve (see attached map).
- Only fishing from the edges is allowed.

#### ARTICLE 3:

The rods must remain under the supervision of the member and within easy reach, it is therefore forbidden to leave them in the process of fishing and at the same time to fish with a spoon around the body of water.

It is also strictly forbidden to entrust fishing rods to a third person.

#### ARTICLE 4:

It is strictly forbidden to dig or modify the profile of the banks, to cut branches, to clear brush, to mow and to set up fishing stations under penalty of immediate and definitive exclusion.

#### ARTICLE 5:

If there were obstacles to the exercise of the right to fish as a result of maintenance work of some nature, the member could not claim any kind of compensation or reduction in the price of the annual share. The municipality would endeavor in such a case to bring to the attention of the members by posting, the days or periods during which the exercise of the right to fish would be restricted or suspended.

#### ARTICLE 6:

Any trade in fish from fishing on the pond is prohibited.

#### ARTICLE 7:

During the time of his presence on the fishing grounds, any member is obliged to present his fishing license to any requisition of the fisheries wardens or law enforcement officers.

#### ARTICLE 8:

The municipality cannot be held liable for any accident or incident of which the member, his spouse, his children or friends are the perpetrators or the victims. The same is true for any incidents or accidents that could occur on the fishing grounds.

#### ARTICLE 9: SANCTIONS

A member who is in one of the following cases may be excluded from his fishing right temporarily (2 months) or permanently:

- non-compliance with the general site regulations (definitive exclusion)
- be intoxicated and / or causing scandal (2 months)
- leaving rubbish on his fishing ground (2 months)
- using radio controlled devices or a boat (2 months)
- guilty of poaching (final exclusion)
- being in default of payment of the sums due (final exclusion)

#### ARTICLE 10:

The member and his companions must comply with the general regulations of the site. This will be given to you at the town hall with the fishing regulations and must be dated, signed and preceded by the words "read and approved".

#### ARTICLE 11:

The municipality reserves the right to modify all or part of these regulations during the year and will undertake to inform the members thereof.

#### ARTICLE 12:

These regulations take effect immediately and until further revision.

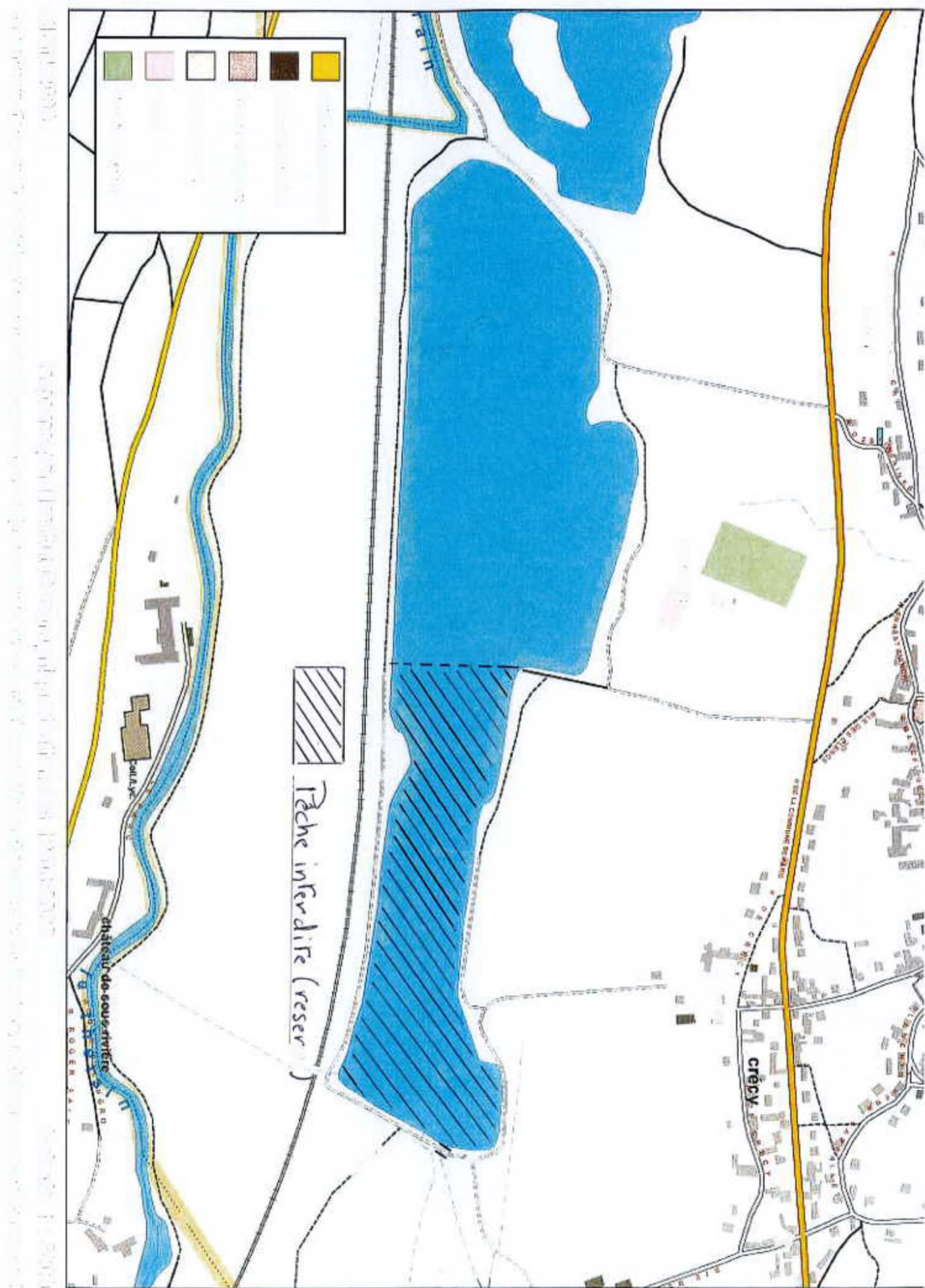

#### **NATURAL SITE PROTÈGÈ**

##### **Are strictly prohibited:**

- motor vehicle traffic
- camping day and night
- picnic outside the areas provided for this purpose
- ground fires or barbecue
- walk outside the marked paths and paths
- picking flowers or plants
- collection of dead wood
- mowing, pruning, wood cutting, brush clearing
- modification of the bank profile
- use of devices that play music
- sound system use
- use of musical instruments
- use of all types of radio controlled devices
- the deposit of waste and garbage
- swimming
- Dogs must be kept on a leash
- to undermine the signage and infrastructure made available to walkers  
(picnic table, fauna and flora interpretation panels)
